STORAGE: Store in original container tightly closed and in a locked, dry, cool, well-ventilated area, away from food, seeds and foodstuffs. Protect from frost. Storage must be generally in accordance with NZS8409 management of Agrichemicals. See HAZNOTE for further information.

USE RATE

POD-LOCK® is used at the rate of 1.0 L/ha.

MIXING:

Three-quarter fill the spray tank with water and commence agitation. Add the required quantity of **POD-LOCK**. Continue agitation while topping up the tank and during spraying. *May be tank mixed with Glyphosate or Diquat.*

DIRECTIONS FOR USE:

POD-LOCK is a unique polymer blend which has been specifically developed to dramatically reduce the quantity of seed shed from seed pods splitting before and during harvest. For use in seed brassica crops including oilseed rape

It does not slow down drying, and has no adverse effects on maturity or quality of seed produced. *It should be applied between pods green and bendy stage (BBCH 80) until fully ripe – nearly all pods ripe, seeds black and hard (BBCH 89).*

Apply in 150-300 L/ha as a medium quality spray. Use the 300 L/ha water volume on dense crops or for maximum effect.

Immediately after application rinse the sprayer thoroughly with water and add *Actiwett™ non-ionic wetter* or *All Clear® tank decontaminant* to clean **POD-LOCK** from the tank, pump, spray lines and nozzles.
